### **I. Minimum Qualification for the posts at Sr. No. 1 to 5 for B.A.B.Ed. Programme.**

- (i) A Master's Degree in the respective subjects Hindi/English/Konkani/History/Geography with 50% marks (or an equivalent grade in a point scale wherever grading system is followed);
- (ii) M.Ed. degree with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and must have cleared the National Eligibility Test (NET) for lecturers conducted by the UGC or similar test accredited by the UGC.
- (iii) However, candidates, who are or have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009 as incorporated in the relevant Goa University Ordinance shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET. (Subject to modification).

## **II. Minimum Qualification for the posts at Sr. No. 6 for B.A.B.Ed. Course.**

- i) Good academic record (shall mean that a candidate has secured at least a second class at graduate level, or has secured an average of 50% marks in the previous three examinations.) with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's Degree level in a relevant subject from an Indian University or an equivalent degree from an accredited Foreign University.
- ii) In addition to fulfilling the above qualifications, candidates must have cleared the National Eligibility Test (NET) conducted by the UGC, CSIR, or similar test accredited by the UGC.

However, candidates, who have been awarded a Ph.D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of Ph.D. Degree) Regulations, 2009, shall be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions.

Provided candidates who were registered for the M.Phil/ PhD Programme prior to July 11, 2009, and have been awarded the PhD Degree, under the provisions of the then existing Ordinances/ Regulations of the Institution awarding the degrees, shall also be exempted from the requirement of the minimum eligibility condition of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions subject to the fulfillment of the following conditions:

- (a) PhD Degree of the candidate awarded in regular mode only;
  - (b) Evaluation of the PhD thesis by at least two external examiners;
  - (c) Open PhD viva-voce of the candidate had been conducted;
  - (d) The candidate has published two research papers from out of his/her PhD work, of which at least one must be in a referred journal;
  - (e) The candidate has presented two papers in seminars/conferences based on his/her PhD work;
- Fulfillment of conditions at (a) to (e) above are to be certified by the Vice Chancellor / Dean (Academic Affairs) / Dean (University Instructions).

## **III. Educational Qualifications and other requirements for System Administrator at Sr. No. 7:**

**Essential:** 1) Bachelor of Engineering (Computer Science / IT) OR M.Sc. (Computer Science / IT) OR Master in Computer Application OR B.Sc. (Computer Science with 3 years industrial experience in Networking and System Administration) OR BCA with 3 years Industrial Experience in Networking and System Administration.

2) Knowledge of Konkani essential.

**Desirable:** 1. Knowledge of Computer Networking and Web Technology.  
Knowledge of Marathi.

## **IV. Educational Qualifications and other requirements for Instructor in Physical Education at Sr. No. 8**

**Essential:** (i) Bachelor Degree in Physical Education (three years course) of a recognized University or equivalent.

OR

(i) Bachelor Degree in Physical Education (two years course) of a recognized University or equivalent along with Bachelor Degree of a recognized University in any other stream or equivalent.

(ii) Knowledge of Konkani essential.

**Desirable:** (i) Master Degree in Physical Education of a recognized University or equivalent.

(iii) Two years experience in teaching / training, in the line of physical education.

(iv) Knowledge of Marathi.

## **V. Educational Qualifications and other requirements for College Counsellor (Contract Basis) at Sr. No. 9:**

**Essential:** 1. Master in Psychology / Human Development from a recognized University / Institution with 55% marks in aggregate.

2. Knowledge of Konkani essential.

**Desirable:** 1. Specialized in Clinical / Counseling Psychology.

2. Minimum experience of 1 year working as a Counselor.

3. Knowledge of Marathi.
