- ii) The appointment may be terminated at any time by a month's notice given by either side, viz, the appointee or the appointing authority, without assigning any reasons. The appointing authority, however, reserves the right of terminating the services of the appointee forthwith and on such termination, the Government Servant shall be entitled to claim a sum equivalent to the amount of her pay plus allowances for the period of the notice at the same rate at which she was drawing them immediately before the termination of her service or, as the case may be for the period by which such notice falls short of the month.
- iii) The appointment carries with it the liability to serve in any part of Goa or any other place outside Goa as directed by his Controlling Officer.
- iv) Other conditions of service will be governed by the relevant rules and orders in force from time-to-time.


