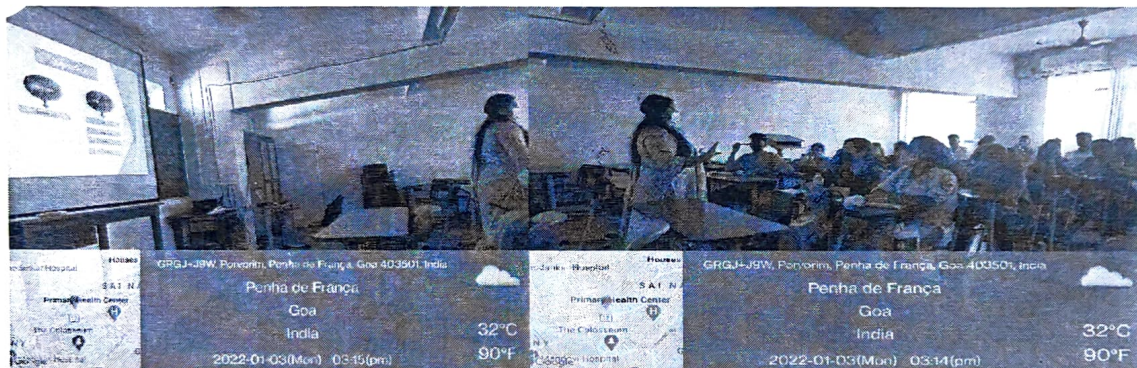

Report

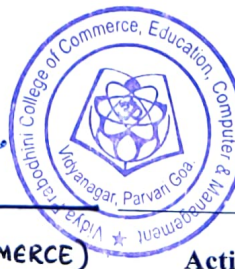

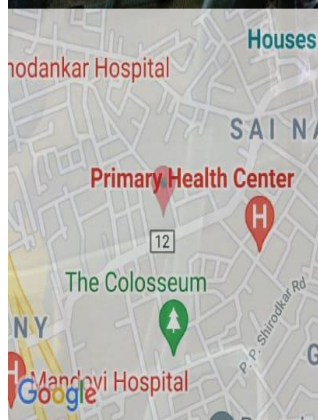
