#### **BACKGROUND OF PARTIES**

# VIDYA PRABODHINI COLLEGE OF COMMERCE, EDUCATION, COMPUTER, AND MANAGEMENT (VPCCECM)

Prabodhan Education Society was founded in 1988 and is dedicated to the cause of promoting Social development through education. Within the short span of 27 years, it runs several institutions imparting quality education right from pre-primary to college. Vidya Prabodhini College of Commerce, Education, Computer and Management is the latest addition to this family started in the year 2012, recognized by Govt. of Goa, affiliated to Goa University and approved by NCTE. The college presently runs two programmes viz, a three-year B.Com., and a four-year integrated B.A.B.Ed. This college takes the privilege of being the first college in Goa to start a B.A.B.Ed. programme from the Academic year 2015-16. The college has well-equipped classrooms with the latest teaching aids like LCD Projectors, smart boards, ICT and modern two-seater tables with chairs.

The college has highly qualified, competent, young and dedicated faculty members who have been constantly working for the all-round personality development of the students. More than 80% of the faculty members are actively engaged in research leading to doctoral degrees. The students have been performing excellent in academics, sports and extracurricular activities. Working beyond working hours, teaching beyond curriculum and innovations in inventions are some of the special features of this institution.

#### DHAVRUKH

In a bid to do our little for environment conservation and to protect the ecology of the area, environmentally conscious youths have initiated an afforestation drive in our village of Mandre since 2017. A resolution to conduct afforestation on the barren hill was subsequently passed in the Gram Sabha of Mandre Panchayat, held on 20th May 2018. So far, over 5 years, the volunteers have planted more than 7000 saplings and have been nurturing them ever since. The initiative was named TREE OF HOPE. After working selflessly for 5 years the group registered the TREE OF HOPE initiative under 'THE SOCIETIES REGISTRATION ACT 1860' by the name "DHAVRUKH" (Reg No. 233/GOA/2021).

Dhavrukh is a registered NGO under the Society Registration Act 1860. It is striving to work towards environmental conservation and creating an environmentally conscious society. Dhavrukh's main objective is to safeguard and protect the environment and to create awareness regarding environment protection & conservation.

#### PURPOSE

The Parties recognize the benefits to be derived from increased collaboration, cooperation and interaction for the promotion and understanding of high performance in awareness activities and organizing various programmes including tree plantation drives, conferences, and other awareness activities. The purpose of this MOU is to define the areas for fundamental, socio-academic aspects in which the Parties desire to work together in the future for their mutual benefit to foster a collaborative framework between DHAVRUKH and VPCCECM in the field to benefit from each other's initiatives and working procedures and to support collaboration among the members associated with both Parties.

#### SCOPE

This MOU sets forth the intentions of the Parties for increased collaboration, cooperation and interaction and does not create any legally binding commitments. If the Parties later agree to undertake specific joint projects with legally binding obligations, they will develop separate written agreements for such projects, setting out each Party's contributions, and deliverables.

#### THE PARTIES INTEND TO:

- Strengthen the ties between DHAVRUKH and academia to make collaborative efforts in the field of Environmental Awareness.
- Collaboration in awareness campaigns and other fields of mutual interest.
- Engage students and scholars in internship programmes.
- Provide free-of-cost mutual access to facilities available for Awareness Programs.

This MoU is signed between DHAVRUKH and VPCCECM for the following deliverables.

#### Deliverables from the DHAVRUKH

- 1. Collaborate in organizing activities related to environmental protection and conservation.
- 2. Providing a platform for students to undergo short projects.
- 3. Organizing events for the promotion of environmental awareness.
- 4. Help the college to promote Sustainable Development Practices.

# Deliverables from the VPCCECM

- 1. The College will allow DHAVRUKH to conduct activities for the promotion and creating awareness among students about the initiatives of DHAVRUKH.
- 2. Motivate students to participate in various programs and tree plantation/maintenance drives organized by DHAVRUKH.
- 3. Logo on all online and offline modes of promotion of the event jointly organized by the college and DHAVRUKH.

## MODE OF OPERATION

Both parties will provide the necessary support for the effective implementation of the MOU within the institutional rules and procedures,

This MoU shall be effective from the date it is signed by both parties.

Within the broad framework of the MOU, Dhavrukh (registered NGO under Society Registration Act 1860) Madhalamaj, Mandrem Pernem - Goa can work on awareness activities plantation drives, development of facilities etc.

Any financial commitment for joint activities under this MoU shall be subject to the approval of the Competent Authorities of the respective organizations.

The activities under this MOU shall be coordinated, monitored and recorded by an Internal Coordination Committee, The President, DHAVRUKH, shall be the internal coordinator from DHAVRUKH whereas The Principal, VPCCECM will be the internal coordinator from VPCCECM.

The visitors will be bound by the rules and regulations, as well as the code of conduct of the host institution.

#### FINANCIAL IMPLICATIONS

This MoU places no financial obligations or supplementary funding commitments on either party. These activities will be defined through separate programme agreements, detailing the commitment of resources (financial or otherwise) required from each institution. Subsequent programme agreements must be approved in advance in writing by the authorized representatives from both Parties. Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU. Where possible and appropriate, the parties may also seek funding for collaborations from the Government and related agencies.

This MoU is also on broad-based understanding between the parties and does not place any financial liabilities on any of the parties. In case there is joint financial involvement between both the parties for any awareness activities it would be decided on an event basis in advance.

### VALIDITY

The Memorandum shall remain in force for a period of three years commencing from the effective date.

#### AMENDMENTS/MODIFICATIONS

This MoU may be amended or modified by a written agreement signed by the representatives of both institutes.
