APPENDIX A RESERVATION GUIDELINES

Reservation of seats for admission to the various Programmes of study shall be on the basis of the Reservation Policy of the Goa State Government.

Candidates applying for admission under the Reserved Categories shall be required to submit a valid Certificate to that effect issued by the Officer of the rank of the Deputy Collector or any other authorized Officer as notified by the Government of Goa.

- 2% of seats in each of the Post Graduate programmes of study, subject to a minimum of one seat, shall be reserved for candidates belonging to SC Category of Goa State.
- 12% of seats in each of the Post Graduate programmes of study, subject to a minimum of one seat, shall be reserved for candidates belonging to ST Category of Goa State.
- 3. 27% of total seats, subject to a minimum of two seats, for admission to various programmes of study, shall be reserved for candidates belonging to the Other Backward Classes Non Creamy Layer (OBC) of the State of Goa as per the directives of the State Government.
- 4. 5% of total seats, subject to minimum one seat for admission to the various programmes of study shall be reserved for Person with Disability (PwD) candidates as per State Government directives.
- 5. 10% of seats, subject to a maximum of two seats and a minimum of one seat in each programme of study, shall be made available for candidates of other Indian Universities.
- 10% of total seats shall be reserved for Economically Weaker Section of Un-Reserved Category (EWS) as per the directives of the State Government.
- 7. 1% of total seats shall be reserved for Children of Ex-servicemen.
- 8. 15% of seats, over and above the allotted number of seats, shall be reserved as supernumerary seats for the overseas candidates, who are eligible for admission and are recommended by the Govt. of India under Scholarship from Govt. of India or under exchange programme (ICCR Programme). These seats shall be filled in accordance with the UGC Guidelines. Out of the 15% supernumerary seats, one seat in each program will be reserved for Kashmiri Migrants (KM) as per directives of the UGC.

Percentage of seats mentioned above is subject to change depending upon the Directives of the Goa State Government.

CIRCULAR

National Commission for Backward Classes has received complaints against the National Law Universities / Schools stating that there are irregularities in the process of admission thereby violating the reservation rules.

National Commission for Backward Classes New Delhi has therefore issued guidelines on 20.1.2020 (A copy enclosed) regarding implementation of reservation in admission. Commission has observed that National Law Universities and State Government Universities which are established under Statutes enacted by the State Legislate and also received grant-inaid from UGC and State Government are not following rule of reservation in admission. The Statute provide reservation for local domicile candidate and for the all Indian seats in their admission. And few of the Universities are providing reservation only in the local domicile percentage of seats and not in the all India seats.

The Commission has therefore recommended that the reservation rules in admission of OBC candidates (27%) in all India seats and local domicile seats may strictly be followed for the admission of academic year starting from 2020 onwards.

All the Government Colleges, Aided Colleges and Goa University shall strictly implement the reservation rule in admission for OBC Categories (27%).

Therefore, Colleges shall maintain the reservation as follows:

1)	Other Backward Classes (OBC)	27%
2)	Schedule Caste (SC)	2%
3)	Schedule Tribes (ST)	12%
4)	Economically Weaker Section (EWS)	10%

All the Government Colleges, Aided Colleges and Goa University shall strictly implement the reservation rule in admission for all above categories in all Indian seats and local domicile seats.

In case any seats reserved for all above categories remain vacant, the same shall be filled by admitting general student.

ADDENDUM

The following paras shall be added after para (6) of the Circular read in preamble at Sr. No. (1):-

Reservation in admission for persons with beachmark disabilities.

It is also stated here that in terms of Section 32 of the Rights of Persons with Disabilities Act, 2016, all Government institutions of higher education and other higher education institutions receiving aid from the Government shall reserve not less that five percent seats for persons with benchmark disabilities.

The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission in institutions of higher education.

All Government/Aided Colleges/Goa University shall follow the above mentioned reservation in admission of persons with benchmark disabilities in all India seats and local domicile seats.

This Addendum supercedes the earlier Addendum dated 28/07/2020 read in preamble at Sr. No. (2).
