# From the Principal's Desk

### **Dear Student**

I am happy to see you considering our college as your preferred choice for bettering your career prospects. The college motto, "Excellence Everywhere, Everytime" has led the institution to various successes over the years, be they in the academic field, cultural stage, or the sports arena, and I am sure, you will find the college will play a significant role in advancing your academic, cultural, sporting needs and aspirations.

The year 2024-45 saw the college banner flying higher than ever. Having picked up prizes galore in the

various student competitions, the college also became the only college in Goa to receive a grant of five crore rupees under the "Grant to Strengthen Colleges" component for the year 2024, initiated by the Government of India under the PM-USHA 3.0 scheme. The college was ranked among the top 300 institutions in India by the National Institutional Ranking Framework (NIRF). And most significantly, the college was awarded an A+ Grade with a CGPA of 3.42 out of 4 in the second cycle of NAAC Accreditation.

Of course, the credit for achieving these three milestones in such quick succession goes to the guidance of the Management, the dedication of the students and staff, and a massive effort by the alumni, the PTA and other stakeholders.

The college has also expanded its infrastructure rapidly. Today, the college boasts of a state-of-the-art board room for organizing meetings and functions, a library that accommodates more than 120 users, and an ICT lab that houses 50 computers equipped with the latest technology. The Department of Physical Education and Sports today offers enhanced sports facilities for students. The Geography laboratory offers updated equipment and literature to cater to the needs of the everchanging industry needs. And, the construction of a new conference hall with a capacity of 500+ seats is in progress on the fourth floor. Plans for other infrastructural developments such as the expansion of the college canteen and the construction of additional classrooms on the fourth floor are soon to be executed.

The college also received an excellent response from prospective students during the academic year 2024- 25, with 122 students admitted to the first-year B.Com. program and 100 to the first-year B.A.B.Ed. programmes. This year, the first batch B.Com. students, who enrolled for the NEP-enabled B.Com. programme, will be answering their Third Year university

examinations, while the B.A.B.Ed. programme will see the 11<sup>th</sup> batch joining the college. The college has also submitted an application to the NCTE for starting the Integrated Teacher Education Program (ITEP), and hopes to start the programme shortly.

The energetic NSS Unit and the vibrant Nisarg Club work proactively on activities such as a beach clean-up drive, Millet week celebrations, Vanamohatsav and promoting of Sustainable Development Goals (SDGs). The College Advisory Committee, Local Managing Committee, Internal Quality Assurance Cell, College Planning Board, the society-centric Red Ribbon Club, the dynamic Parent-Teacher Association (PTA) and Alumni Association play an active role in keeping the institution on track and in tune with the students' aspirations. The active Placement Cell organizes regular placement drives for interested students, providing students with valuable employment opportunities. The college also runs the Indira Gandhi National Open University (IGNOU) Study Centre-08033, which has been operating on campus since 2017, expanded its offerings this year. The centre, which provides seven bachelor's programs and one postgraduate diploma, introduced postgraduate programs such as the M.Sc. in Geography and the M.A. in Rural Development and has enrolled over 2,000 students during the past academic year. The college regularly organizes national and statelevel conferences and workshops and seminars for academicians, industry and students, including a two-day national conference titled, "Gender Writes: A Dialogue on Rewriting the Gender Narrative", that saw Prof. Santishree Pandit, Hon'ble Vice-Chancellor of Jawaharlal Nehru University, New Delhi, as the keynote speaker. The college also boasts of associations with industry leading organisations such as the BSE, GCCI, Putzmeister, Muthoot Finance, TJSB and India Post Payments Bank. Furthermore, the college runs a number of certificate courses with several of these organisations, and trains students for various competitive exams including the UPSC, GPSC and TET.

The college has everything and more to offer you. And, I am sure, all your aspirations and dreams will find a home at this place we call the VPC Parivar!

# Admission Process for the Academic Year 2025-2026

The admission procedure for the academic year 2025-26, will be conducted on the SAMARTH portal of DHE through online mode only.

You are required to follow the instructions for completing the Admission process provided on the DHE website (www.dhe.goa.gov.in) and also on the College website (vidyaprabodhinicollege.edu.in) from time to time.

Reservation under various categories will be as per the reservation policy of the Government of Goa.

The following are the competent authority for issuing certificates for reservation:

- 1. OBC/SC/ST: Office of Deputy Collector
- 2. Income Certificate for EWS: Office of the Mamlatdar.
- 3. Persons with Disabilities(PWD): Medical, Superintendent of either GMC / District Hospital. (and/or any other authority designated by the Government of Goa).

As per the circular dated 24/03/2025, issued by the Directorate of Higher Education, Government of Goa, the detailed guidelines and timeline for the Undergraduate (UG) admission process for the academic year 2025 are as follows:

1. UG Online Admission 2025 will be conducted on the SAMARTH e-Gov platform:

### https://goaadmission.samarth.ac.in/

- 2. The online application process will commence from 11th April, 2025, 11:00 AM onwards.
- 3. The first round of the online application process will remain open until 12th April 2025, midnight.
- 4. All colleges are requested to update the SAMARTH portal admission link on their respective college web portals.
- 5. All colleges must upload their e-prospectus on their respective college web portals.
- 6. Applicants who have passed, are appearing for, or are awaiting their 12th standard results shall be eligible to apply for the UG programs.
- 7. Admissions for all aided and self-financed UG programs offered in the colleges under the administrative control of DHE Goa shall be conducted on the SAMARTH e-Gov portal.
- 8. Each candidate applying for UG program is required to register only once on the SAMARTH e-Gov portal.
- 9. Candidates can apply to a maximum of five colleges/programs of their choice.
- 10. Candidates can apply to multiple programs in same college as well.
- 11. The online application process is free of cost.

### **Mandatory Documents for Admission**

- 1. Application form
- 2. Original mark sheet of H.S.S.C./equivalent examination
- 3. Original copy & one self-attested copy of the H.S.S. Leaving Certificate.
- 4. Two hard copies of recent passport-sized photographs.
- 5. Anti-Ragging Undertaking form.
- 6. Identity card slip
- 7. Eligibility Certificate (in original) issued by Goa University and a Migration Certificate (for those students who have passed Std. XII or any other equivalent examination through any other recognized Board other than Goa Board, if applicable).
- 8. Signing Code of Conduct undertaking of the college.
- 9. Students belonging to Reservation category should furnish the valid certificate issued by the competent authority while submitting admission forms.

### NOTE:

- i. The presence of Parent/Guardian is compulsory during the admission.
- ii. The admission will be done purely on Open 'Merit Basis'.
- iii. Subject allocation to be done on purely merit basis and availability of seats.
- iv. Separate scanned copies of each of the above documents are required at the time of filling the online application form.

# **B.Com. Programme under NEP**

The Curriculum and Credit Framework for Undergraduate Programme under National Education Policy (NEP) 2020. Excerpts from Ordinance OA-38

### Bachelor of Commerce and Bachelor of Commerce (Honours)

The college offers students three programmes to choose from:

- 1. B.Com. (Financial Accounting) with Honours
- 2. B.Com. (Cost Accounting) with Honours
- 3. B.Com. (Business Management) with Honours

The Curriculum and Credit Framework for Undergraduate Programmes (CCFUP) under National Education Policy (NEP) 2020 envisages the incorporation of a flexible choice-based Credit system, multidisciplinary approach with multiple entry and exit options, to facilitate students to pursue their career path by choosing the subject/field of their interest.

### OA-38.2 OBJECTIVES

The General Objectives of the Programme shall be:

- (i) To recognize, identify, and foster the unique capabilities of each student to promote her/his holistic development.
- (ii) To provide flexibility, so that learners can select their learning trajectories and Programmes, and thereby choose their own paths in life according to their talents and interests.
- (iii) To impart multidisciplinary and holistic education across the sciences, social sciences, arts, humanities and sports.
- (iv) To emphasize on conceptual understanding rather than rote learning; critical thinking to encourage logical decision-making and innovation; ethics, human & constitutional values; life skills such as communication, teamwork, leadership, and resilience.
- (v) To encourage extensive use of technology in teaching and learning, removing language barriers, increasing access for Divyang students, and educational planning and management.
- (vi) To provide respect for diversity and respect for the local context in all curricula, pedagogy and policy.
- (vii) To uphold equity and inclusion as the cornerstone of all educational decisions, to ensure that all students are able to thrive in the education system, and the institutional environment is responsive to differences, to ensure that high-quality education is available for all.
- (viii) To have rootedness and pride in India, and its rich, diverse, ancient, and modern culture, languages, knowledge systems, and traditions.

### OA-38.4 DURATION OF THE PROGRAMME

- (i) The duration of the UG Programme shall be of Four Years/Eight Semesters with multiple entry and exit options.
- (ii) A student may also be permitted to take a break from the Programme during the period of study.
- (iii) The total duration for completion of the UG Programme shall not exceed seven years from the date of initial registration.
- (iv) Every Academic Year shall consist of two Semesters.
- (v) In addition, there shall be a Summer Term during the vacation.

### OA-38.4.1 UG CERTIFICATE/UG DIPLOMA AND DEGREES TO BE AWARDED

The following Certificate/Diploma/Degrees shall be awarded as below:

- (i) UG Certificate (NCrF Level: 4.5): Students exiting on completion of 1 year (2 Semesters) of study in the chosen broad discipline having fulfilled the Credit requirement and successfully completed a 4 Credit Vocational Course during the summer term (vacation) of the first year.
- (ii) UG Diploma (NCrF Level: 5): Students exiting on completion of 2 years (4 Semesters) of study in the chosen broad discipline having fulfilled the Credit requirement and successfully completed a 4 Credit Vocational Course during the summer term (vacation) of the second year.
- (iii) Bachelor of Arts/Bachelor of Commerce / Bachelor of Science/ Bachelor of Computer Applications/ Bachelor of Business Administration/Bachelor of Social Work/Bachelor of Performing Arts and such other Degrees (NCrF Level: 5.5): after the successful completion of 3 years in the Programme and the related Credit requirements, as specified elsewhere in this Ordinance.
- (iv) Bachelor of Arts/Bachelor of Commerce/Bachelor of Science/Bachelor of Computer Applications/Bachelor of Business Administration/Bachelor of Social Work/Bachelor of Performing Arts (4 years Honours) and such other Degrees (NCrF Level: 6): after the completion of 4 years in the Programme and the related Credit requirements, as specified elsewhere in this Ordinance.
- (v) Bachelor of Arts / Bachelor of Commerce /Bachelor of Science/ Bachelor of Computer Applications/ Bachelor of Business Administration/Bachelor of Social Work/Bachelor of Performing Arts (4 years Honours with Research) and such other Degrees (NCrF Level: 6): after the completion of 4 years in the Programme and the related Credit requirements, as specified elsewhere in this Ordinance.
- (vi) Interdisciplinary or Multidisciplinary Degree: Students who opt for 3 year or 4 year Degree Programmes shall be awarded a degree in Interdisciplinary or multidisciplinary subjects as the case may be.
  - (a) Interdisciplinary Degree: A student who opts for interdisciplinary subjects shall be awarded a Bachelors Degree/Bachelors Degree (Honours)/Bachelors Degree (Honours with Research) in Interdisciplinary Subjects. For example if a student opts for subjects like Chemistry, Zoology and Botany s/he shall be awarded a BSc in Interdisciplinary Subjects (Chemistry, Zoology and Botany)
  - (b) Multidisciplinary Degree: A student who opts for multidisciplinary subjects like Mathematics, Finance and Economics will be awarded a Bachelors Degree/ Bachelors Degree (Honours) Bachelors Degree (Honours with Research) in Multidisciplinary Subjects (Mathematics, Finance and Economics).

### OA-38.5 ELIGIBILITY FOR ADMISSION

The eligibility for admission to the Four Year UG Degree Programme shall be as follows:

- (i) The Higher Secondary School Certificate (Std. XII) examination conducted by the Goa Board / equivalent body, after successful completion of Grade 12 or equivalent stage of education corresponding to Level-4.
- (ii) A student not covered under any of the above categories but desirous of seeking admission to the said Programme may apply to the University /College. However, the Vice Chancellor along with Dean of the concerned School/Faculty and Chairperson(s) of Board(s) of Studies of concerned subjects shall decide the eligibility in such cases.
- (iii) A student admitted for Semester-I /III/V/VII shall be deemed eligible for admission to Semester-II/IV/VI/ VIII, of each respective year provided;
  - a) S/he has no backlogs of previous Semesters to be eligible for admission to Semester V.
  - b) S/he has no backlogs of Semester V and VI to be eligible for admission to Semester VII.
- (iv) A student migrating from another recognized University and desirous of direct admission to UG Programme shall be eligible for admission based on the earned Credits in the subjects for which admission is sought. This is subject to the provisions of the Academic Bank of Credits (ABC) Ordinance of Goa University. The Vice-Chancellor along with Dean of the concerned School/Faculty and Chairperson(s) of Board(s) of Studies of concerned subjects shall decide the eligibility.

- (v) A student with a UG Certificate shall be eligible to take admission in the Third Semester of the Degree Programme within three years of exit and complete the Degree Programme within the stipulated maximum period of seven years.
- (vi) A student with a UG Diploma shall be eligible to take admission in the Fifth Semester of the Degree Programme within a period of three years of exit and complete the Degree Programme within the maximum period of seven years.
- (vii) A student who has exited with a UG Degree shall be eligible to take admission in the Seventh Semester of the Degree Honours Programme within a period of three years and complete the Degree Honours Programme within the maximum period of seven years.
- (viii) A student who obtains 75% and above or equivalent CGPA of the total marks obtained in the first Six Semesters shall be eligible to take admission to the four-year Degree (Honours with Research) at the Seventh Semester. The equivalent CGPA shall be 8.25 as per the CGPA calculation given in this Ordinance.
- (ix) The seven years duration shall be counted with effect from admission by him/her to the first Semester of UG Programme.

### OA-38.5.1 LATERAL ENTRY FOR STUDENTS REGISTERED UNDER OC-66

- (i) Students already enrolled in the UG Programme under Choice Based Credit System (CBCS) shall be permitted to seek admission to the Four-year Undergraduate Programme effective from Academic Year 2024-2025.
- (ii) The concerned Institution shall provide Bridge Courses (including online Courses) approved by the Board of Studies to enable students to transition from CBCS to CCFUGP.

### OA-38.5.2 CLASS/DIVISION STRENGTH

- (i) Ordinarily, the number of students in a class/division shall not exceed sixty.
- (ii) The University shall permit 10% additional seats to accommodate requests for a change of Major wherever required.
- (iii) Any unfilled or vacant seats shall be filled with those seeking a change of Major.
- (iv) Preference shall be given to those who scored highest CGPA and have no backlog in the first year.

### OA-38.7 COURSES AND COURSE STRUCTURE

- (i) A Course shall consist of either of the following:
  - (a) Only theory component,
  - (b) Only practical component or,
  - (c) Both theory and practical components.
    - For Courses which have both theory and practical components, the ratio of 75% theory and 25% practical shall be maintained with separate heads of passing. However, in case of Skills Enhancement Courses (SEC) and Vocational (Exit) Courses the emphasis shall be on hands on training/Practical component. The pedagogy for a Course shall include any of the following: Lectures, tutorials, practicum, seminar, internship, studio activities, field/laboratory projects, community engagement and such others or a combination of the above forms as recommended by the Board of Studies.
- (ii) A Programme shall comprise of the following categories of courses:
  - (a) Disciplinary/Interdisciplinary Major (Core) A Major course will provide a student the opportunity to pursue in-depth study of a particular subject or discipline. Credits earned by a student from the two Major Courses of the Broad Discipline/Discipline in Semester I and II shall be counted towards total Major Credits.
  - (b) Disciplinary/Interdisciplinary Minors Students may opt for Minor courses from Disciplinary/Interdisciplinary areas including skill- based courses relating to a chosen Vocational Education and Training. Students, who successfully complete the requisite number of courses (as specified in the OA-38 12.2 & 12.3) in a Disciplinary or an Interdisciplinary area of study other than the chosen Major, shall qualify for a Minor in that discipline or in the chosen Interdisciplinary area of study. To qualify for a

Minor, a student shall have to earn a minimum of 12 Credits in the chosen Minor. A student shall declare at the end of Semester II the subjects s/he wishes to opt for under Minor.

- (c) Vocational Education and Training (VET) VET shall form an integral part of the UG Programme to impart skills along with theory and practical. A minimum of 12 Credits will be allotted to the Minor stream relating to VET which can be related to the Major or Minor Discipline or choice of the student. A student shall have to declare subject/courses under VET at the end of Semester II. In case of Programmes such as BBA, BCA internship could be offered in lieu of VET.
- (d) Multidisciplinary Courses (MC)

UG students shall be required to undergo Three Introductory-level courses relating to any Broad Discipline that they have not undergone at the HSSC level as given below:

Natural and Physical Sciences, Mathematics, Statistics and Computer Applications Library, Information and Media Sciences, Commerce and Management, Humanities and Social Sciences.

(e) Value-Added Courses (VAC)

The following are the VAC common to all UG students:

Understanding India, Environmental Science/Education, Digital and Technological Solutions, Health & Wellness, Yoga Education, Sports, Fitness, courses related to National Service Scheme (NSS), National Cadet Corps (NCC) and such other courses. However, a two Credit Environmental Science Course shall be mandatory under VAC.

(f) Ability Enhancement Courses (AEC)

Students shall achieve competency in a Modern Indian Language (MIL) and in the English Language with special emphasis on communication, reading and writing skills. Foreign National/ Person of Indian Origin/Non-Resident Indian/Foreign Board students may opt for additional English Language Courses or any other Foreign Language Courses in lieu of MIL.

(g) Skills Enhancement Courses (SEC)

SECs shall focus on practical skills, hands-on training, soft skills and such other courses to enhance the employability of students.

(h) Summer Internship / Apprenticeship (I)

Students shall be provided with opportunities for Internships in the summer term. Students shall undergo Internships in a Firm, Industry, Organizations, Laboratory with Faculty and Researchers (in their own or other HEIs), Health and allied areas, Local Governments (such as Panchayats and Municipalities), Parliament or elected representatives, media, artists, crafts persons, NGOs and other such organizations to improve their employability.

(i) Community Engagement and Service (CES)

Through CES students shall be exposed to socio-economic issues in society to enable them to generate solutions to real life problems. CES shall be offered either as a part of the summer term activity or part of Major or Minor Course depending upon the Major Discipline.

(j) Project/ Field-Based Learning (P)

The Project work shall be compulsory and shall be offered in lieu of a Major Course. Field-based learning may be a part of summer term activity.

(k) Dissertation (D)

A student opting for a 4-Year Bachelor"s Degree (Honours with Research) shall have to complete a 12 Credits Dissertation under the guidance of a Faculty member. An Internship shall be offered In lieu of Dissertation where Internship is an integral component of the Curriculum.

(I) Extra-curricular Activities (EA)

Sports, Adult Education/Literacy initiatives, mentoring school students and other similar activities. National Service Scheme (NSS) and/or National Cadet Corps (NCC) courses that are not opted by a student asVAC may be permitted under EA.

### OA-38 7.1 COURSES OPTED FROM OTHER INSTITUTES:

Students shall be permitted to opt Credits/Course from any other Colleges/Institutions affiliated to the Goa University.

### OA-38.14 SCHEME OF EXAMINATION

The Scheme of Examination shall be as follows:

- (i) Evaluation shall be based on continuous assessment, in which Intra-Semester Assessment (ISA) and Semester End Assessment (SEA) will contribute to the final grade. ISA will consist of class tests, mid-Semester examination(s), homework assignments, and such other modes of evaluation, as determined by the faculty in charge of the courses of study. Progress towards achievement of learning outcomes will be assessed using the following: time-constrained examinations; closed-book and open book tests; problem-based assignments; practical assignment, laboratory reports; observation of practical skills; individual project reports (case-study reports); team project reports; oral presentations, including seminar presentation; viva voce; computerized adaptive assessment, surprise test, modular certifications, and any other modes of assessment.
- (ii) The evaluation for the Courses shall comprise of ISA and the SEA.
  - (a) One Credit shall carry 25 marks.
  - (b) The ISA shall carry 20% of maximum marks allotted for the Course, and SEA shall carry 80% marks. A Course of Four Credits for total of 100 marks, having only Theory, shall have ISA for 20 marks and SEA for 80 marks.
  - (c) There shall be no ISA for the One Credit Practical Component of Four Credit Courses. A Four Credit Course (100 marks) comprising Theory (Three Credits) and Practical (One Credit) shall have ISAs only for the Theory Component (15 Marks), and SEA Theory Component (60 marks). The One Credit Practical Component has only SEA (25 marks).
  - (d) There shall be no ISA for a One Credit Practical Course.
  - (e) In case of Two-Four Credit Practical Courses, the ISA shall have 20% weightage and SEA 80%.
  - (f) Courses of any other number of Credits shall have a proportionate marking system.
- (iii) Intra-Semester Assessment (ISA)

There shall be three ISAs in a given Semester for the theory Component of each Course of 2 Credits and above, of which a minimum of 50% shall be evidence based. The two best scores shall be considered for the final ISA marks for papers of 2 Credits and above. For a course of one Credit the best score out of two ISAs shall be considered. ISAs may be through a written test or any other alternative mode of evaluation, including assignments, presentations, oral or online test, MCQs, open book test, and any other mode of assessment.

- (a) There shall not be any averaging of ISA marks.
- (b) Generally, the ISA for a given Course shall be conducted by the teacher/s teaching that Course.
- (c) The ISA schedule shall be notified at the beginning of the Semester.
- (d) ISA marks shall be communicated to students within two weeks of the ISA.
- (e) Ordinarily, ISA-I shall be completed by the end of the Fifth week after the commencement of the Semester and ISA-II by the end of the Tenth week of the Semester.\
- (f) Students who fail to appear for an ISA due to a genuine reason shall be given another opportunity, to complete the ISA.
- (g) There shall be a Committee appointed to monitor the conduct of ISAs.

- (h) To be eligible to appear for the Semester End Assessment (SEA), a student shall be required to appear for a minimum of two ISAs in each Course.
- (iv) Semester End Assessment (SEA)
  - (a) SEAs shall be conducted at the conclusion of every Semester, and shall cover the entire syllabus prescribed for the respective Course.
  - (b) A student shall be considered to have successfully fulfilled the requirements of a Semester to be eligible to appear for the SEA provided the student has appeared for two ISAs in a Course, and fulfils the minimum attendance requirements as per the relevant rules of the University. A student failing to fulfil these conditions shall have to repeat the course.
  - (c) The detailed procedure for the conduct of SEA and subsequent assessment shall be as notified by the University.
  - (d) The pattern of question paper(s) to be set for the SEA in a given course and the scheme of marking shall be decided by the respective BoS. For this purpose, the BoS shall frame specimen question paper(s) in the various courses concerned for the information of the students. Similarly, for practical examinations, the number of laboratory exercises, marks distribution for each exercise and other relevant details shall be decided by the respective BoS.
  - (e) To pass a Course a student shall have to obtain a minimum of 40% in ISA and SEA together. There is no separate passing for ISA and SEA.
  - (f) The duration of SEA theory paper carrying up to 40 marks shall be 1 hour, and papers of above 40 and up to 80 marks shall be of 2 hours duration.
  - (g) Supplementary exams shall be held at the end of the academic year immediately after SEA.
- (v) Paper Setting

The detailed procedure for the paper setting of shall be notified by the University.

- (vi) SWAYAM Courses Students shall have the option to earn up to 40% of the Credits through online SWAYAM Courses recommended by the Board of Studies and approved by Academic Council preferably in the beginning of each Semester. Students shall inform Programme Director/Head of the Department before registering for the SWAYAM Courses. The certificates/marks obtained by the students after successful completion of SWAYAM course/s has to be forwarded to the Controller of Examination along with Semester marks through the Principal of the College/Dean of the Schools for uploading the Credits in the Academic Bank of Credits (ABC) account of the student.
- (vii) Students shall be permitted to opt Credits/Course from any other Colleges/Institutions affiliated to the University. The assessment and evaluation of the Course shall be conducted by the concerned College/Institution offering the Course, the Institution shall be responsible for forwarding the marks to the parent institution where student is enrolled for the Programme for further processing.

### OA-38.14.1 PRACTICAL EXAMINATION

- (i) Conduct of Examination
  - (a) Examination(s) in Laboratory exercises shall be conducted for Courses with a practical component. Marks will be allotted as follows: Experiment (including Field Work) 60%, Journal/Record Book 20%, Oral Examination 20%. A student shall be permitted to appear for the practical examination only if s/he submits her/his journal duly certified by the teacher(s) teaching the Course and the concerned Head of the Department/Programme Director.
  - (b) To assess the student"s performance in the assigned experiment, the examiner shall take into account the planning, procedure, techniques followed, readings/observations, results and the presentation. (c)

Students shall be required to submit the journal/record book before the practical examination. Examiner(s) shall take into account the regularity of the student in attending the Laboratory Course, completeness of the exercises and presentation and format of the journal. For subjects having field work component, the student shall be required to submit the report of such field excursion(s) along with the journal(s) for assessment. The examiner(s) shall consider the report along with journal(s) while allotting marks.

- (d) In the oral examination, examiner(s) shall assess the knowledge of a student in the Course as well as during the experiment(s) performed.
- (e) Record of the breakup of marks obtained by the student for Semesters I to VII for the examinations conducted by the College, shall be maintained by the College in a sealed envelope for a minimum period of one year.
- (f) A student unable to appear for the practical examination on medical or other genuine grounds may be permitted to appear for a practical examination out of turn, irrespective of the timetable and the batch allotted to him/her, in the examination. This out of turn appearance may be in the same Institution or in a different Institution. Such permission shall be granted by the University if recommended by the respective Dean or Principal of the College. The student shall be required to remit the requisite fee for this out of turn examination.

### OA-38.14.2 EVALUATION OF DISSERTATION

The Research Supervisor along with the faculty members of the concerned Discipline shall assess the Dissertation work as per the components below:

- (i) Research Conceptualization: The Research Conceptualization shall have only one assessment component of 100 marks at the beginning of the Semester VIII for the Four-Year Undergraduate Degree Programme which shall be in the form of a presentation of the research frame, identification of the research gap through a review of literature and availability of data, compiled by the student in Semester VII. 50% of the marks shall be awarded by the Research Supervisor and 50% by the faculty members of the Department/Discipline.
- (ii) Research Mentoring: -

The Research Supervisor shall continuously monitor the progress of research work, evidenced by attendance over Semesters VII and VIII, and shall award marks for research work and the Research Report submitted by the student out of 100 marks. The Research Supervisor shall also take into account the student's discipline, sincerity, interest and performance.

### (iii) Research Report:

The Research Report shall also be evaluated by an External Examiner for 100 marks. The External Examiner shall be a PhD holder in the concerned subject.

- (iv) A student who fails in the Dissertation shall have to resubmit the Dissertation after incorporating changes suggested by the External Examiner. If there is further rejection of the Dissertation, the candidate shall have to change the topic of Dissertation in consultation with a guide and submit in the next Semester.
- (v) Evaluation of Internship:
  - (a) The modalities of internal evaluation shall be decided by BoS.
  - (b) The students on internship shall be under the mentorship of faculty member/s. The mentor faculty shall orient the students on Internship and outline the expected learning outcomes from Internship. The mentor faculty shall be expected to monitor and periodically assess the progress.
  - (c) There shall be an ISA component of 20% marks and SEA component of 80% marks.
  - (d) The faculty mentoring the student shall assign ISA marks based on the feedback obtained from company/ organization and the domain knowledge, skill set, best practices learned by the student at the organisation/

company and such others. BoS can devise suitable evaluation techniques to assess the ISA component.

- (e) SEA marks shall be based on Internship Report and presentation and shall be decided by the Department/ Discipline faculty members. The Internship Report shall be prepared in line with the Dissertation report for the purpose of evaluation.
- (f) For BBA and BCA, Internship in lieu of each VET course shall be assessed for 100 marks with ISA and SEA components.
- (g) The scheme of evaluation of Exit requirement of 4 Credits shall be as per OA-38 14.2(v)(c).

#### OA-38.14.3 EVALUATION OF PROJECTS OFFERED AT SEMESTER VI.

- (i) A Project, in lieu of a Major Course, shall be offered in Semester VI. Ideally, the Project shall be a Group Project with a maximum of five students per group. A teacher shall not ordinarily be assigned more than two Projects. The Project workload will be two hours per Project per week for a group of four or more students. For a group of three or less students the workload will be one hour per week per Project.
- (ii) Project and the Report shall be based on field work/library work /laboratory work/ on-the-job training or similar work assigned by the teacher.
- (iii) The Project Supervisor shall ensure that the content in the Project Report is not plagiarized.
- (iv) The assessment of the Project shall be done by the Internal Examiner (Project Supervisor for 20 marks) and External Examiner (for 80 marks) as per the Guidelines defined in the Project Manual.

### OA-38.14.4 VERIFICATION AND REVALUATION OF MARKS.

- (i) Revaluation of SEA answer books in Semesters I to VIII shall be permitted as per the existing provisions of OA-5.15 for Revaluation/Verification.
- (ii) All grievances pertaining to ISA marks shall be dealt with by the Grievance Committee of the College before sending the ISA marks to the University.
- (iii) ISA marks shall be submitted to the University within 20 days of the conduct of the last ISA.
- (iv) Verification of only SEA theory papers is permitted.

### OA-38.15 AWARD OF GRADES

Award of Grades shall be as per Ordinance OA - 16.

### Student Attendance for B.Com. Programme

Minimum attendance for eligibility to appear for examination conducted by Goa University is in according with Goa University Ordinance OA-17. A student registered in a semester/term/year, for any course(degree or diploma), shall be required to have a minimum cumulative attendance of 75% of the total lectures and practicals prescribed for the course during that semester/term/year. Although the attendance shall be cumulative for all the papers/course taken together in the given semester/term/year, a student shall be required to have a minimum of 50% attendance in any individual paper/course. A student having less than 75% cumulative attendance in a semester/term/year and/or less than 50% attendance in individual paper/course, shall not be eligible to appear for that semester/term/annual examination. Attending the morning assembly is compulsory.

### Student Uniform for B.Com. Programme

As per the directives of the Department of Higher Education (DHE), it is mandatory for all students to wear the prescribed uniform while attending classes and participating in college activities. The uniform is an integral part of our institution's identity and is designed to promote a sense of discipline, equality, and professionalism among students. Therefore, all students are required to wear the uniform issued by the college.

# **B.A.B.Ed. Programme**

The College takes credit for having started a unique program i.e. a Four-Year integrated B.A.B.Ed from the Academic Year 2015-16. The Four-Year Integrated Bachelors of Arts and Bachelors of Education Programme, approved by the N.C.T.E. (National Council for Teacher Education) Govt. of India and the Government of Goa, is affiliated to Goa University under Section 24(1) of the Goa University Act (1984). The B.A.B.Ed. programme is governed by the Goa University Ordinance, OC-54, relating t o the Four-Year Integrated Programme leading to the award of the degree of Bachelor of Arts and Bachelor of Education (B.A.B.Ed.) (w.e.f. academic year 2015-16). The degree shall be Bachelors of Arts and Bachelors of Education (B.A.B.Ed.), and shall be awarded after the successful completion of the program. Notwithstanding anything contained in the ordinance, a successful candidate of the B.A.B.Ed program shall not be entitled for separate degrees of B.A and B.Ed.

### Learning outcomes

The course will enable learners to deploy suitable methods, strategies and techniques of teaching to achieve instructional objectives at school level. Manage classroom environment to ensure effective learning. Demonstrate basic understanding of chosen social science and language electives. Conduct research to improve process and product of education.

### Career opportunities

On successful completion of the program the B.A.B.Ed. graduates can opt for teaching career in the elementary and secondary schools. They can also become educational counsellor, practitioner or an edupreneur. Can pursue Post Graduate Studies in their respective subjects studied in 'Under Graduate' level, after their Post-Graduation they may do Ph.D. and take teaching as their career in higher education institutions like Degree colleges and Universities.

### OBJECTIVE

The objective of this course is to create competent and trained human resource in the field of Teaching and Education in the society, to draw talented and vocationally inclined youth (after HSSC or equivalent) in the vitally significant teaching profession and to infuse a sense of purpose and commitment in the aspiring teachers at a fairly early stage in their education. The program is under the faculty of Education without any lateral exit. An integrated approach to the teaching of languages and Social Science subjects is followed throughout the teaching program. Fine Arts, Performing Arts, Physical Education, Work Experience, Health Education and Working with the Community are also an integral part of the curriculum as per recommendations of the National Council for Teachers Education (NCTE). A core training program for developing teaching skills has also been introduced as a part of the program. The B.A.B.Ed. program is a full-time program of eight semesters, with a provision of vertical mobility towards M.A. and/or M.Ed.

### **ELIGIBILITY FOR ADMISSION**

There are 100 seats sanctioned for the programme. To be eligible for admission to the B.A.B.Ed. Programme, a candidate must have passed the XIIth standard examination of 10+2 pattern of the Goa Board of Secondary and Higher Secondary examinations recognised as equivalent thereto by the Goa University, with a minimum percentage of 50% as per NCTE norms. Reservation under various categories will be as per the reservation policy of the Government of Goa.

- (i) Eligibility for admission to Second Year B.A.B.Ed.:
  - Candidates who are eligible to appear for examinations of Semesters I and II shall be eligible for admission to the Second Year, irrespective of backlogs in Semesters I and II.
- (ii) Eligibility for admission to Third Year B.A.B.Ed.:
  - Only those candidates, who have passed Semester I and II, fulfilled the requirement of the Semesters III and IV, and have not more than five papers as backlog from Semester III and IV together, shall be considered eligible for admission to the Third Year.
- (iii) Eligibility for admission to Fourth Year B.A.B.Ed.:
  - Only those candidates, who have passed Semesters I, II, III and IV, fulfilled the requirement of the Semesters V and VI, and have not more than five papers as backlog from Semesters V and VI together, shall be considered eligible for admission to the Fourth Year.

### **ENTRANCE TEST AND ADMISSION**

The admission procedure to the program shall be as determined by the state Government/University.

### **LECTURE TIMINGS**

Students are required to be on campus during the entire duration as given below:

- 1. Monday to Saturday: 8:30am to 5:30pm. Attending the morning assembly is compulsory.
- 2. In addition, students will be required to go for internships and other field work.

### OC-54.3 SCHEME OF EXAMINATION

OC-54.3.1 There shall be continuous Intra-Semester Assessment (ISA) and Semester End Examination (SEE), for each of the Programmes. Examinations in Laboratory exercises shall be conducted for Courses having practical component.

- (a) (i) The continuous ISA shall be conducted by using various modes of evaluation such as assignment, presentation, orals, of which a written test shall form a compulsory component. Generally, ISA for a given Course shall be conducted by the teacher(s) teaching that Course. ISA shall not be conducted for the Practical component of a Course. The schedule for the ISA component shall be notified to all at the beginning of the semester. The marks of ISA shall be communicated to the students within two weeks.
  - (ii) (a) (Notified on 25th July, 2017)The ISA components of Courses that do not have a practical module, shall carry 30% of maximum marks and the SEE components shall carry 70% of maximum marks allotted for the courses.
    - (b) (Notified on 25th July, 2017)For Courses that have a practical module, the Practical component shall be assessed for 25% marks and the Theory component for 75% marks. The ISA for Theory shall carry 20% of maximum marks and the SEE shall carry 80% of maximum marks allotted.
    - (c) (Notified on 25th July, 2017)The ISA components for Education related Courses that have a practical component shall carry 40% of maximum marks and the SEE components shall carry 60% of maximum marks allotted for the courses.
  - (iii) Every College shall appoint a three member committee to monitor the ISA in the college. There shall be no remission in workload or remuneration for carrying out this work.
  - (iv) A student who fails to appear for a test due to a genuine reason shall be given another opportunity.
  - (v) A student who does not appear for the ISA tests shall not be eligible to answer SEE of that Course.
- (b) (i) The SEE shall be conducted at the conclusion of a given Semester.
  - (ii) A candidate shall be considered to have successfully fulfilled the requirements of a Semester and deemed eligible to appear for the SEE provided he/she fulfills the minimum attendance requirements as per the relevant Ordinance of the University.
  - (iii) A tentative schedule of SEE examination, evaluation, declaration of results, and such matters, shall be prepared by the respective College(s), preferably at the beginning of each academic year for first four Semesters and shall be notified to the students with a copy to the University. Setting of the question papers, evaluation of answer-scripts and declaration of results shall be done by the respective College.
  - (iv) The pattern of question papers to be set for the SEE in a given subject and the scheme of marking shall be decided by the Board of Studies in that subject. For this purpose, the Board of Studies shall frame specimen question papers in the concerned subject for each semester for the information of the students. If two or more Colleges desire to have the same question paper in any of the subjects, a common paper may be set by the teachers from the concerned college. For this purpose, a Committee of senior teachers shall be constituted by the Principal of the concerned College.
  - (v) Assessment of answer-scripts of SEE of Semesters I to IV shall be organized by the colleges. The assessment of the SEE answer scripts at the Semesters I to IV shall be done by the teachers of respective colleges.
  - (vi) (Notified on 25th July, 2017) The Schedule of the Examination and the setting of question papers for SEE for Semesters V to VIII shall be done centrally by the University, by the paper setters designated

for the relevant subjects of the B.A.B.Ed. and B.Sc.B.Ed. Programmes.

- (vii) (Notified on 25th July, 2017) The duration of SEE theory paper carrying up to 30 marks shall be of one hour; the theory paper carrying above 30 marks up to 40 marks shall be of one and half hour, and the theory paper carrying above 40 marks up to 80 marks shall be of two hours.
- (c) (i) For Courses having practical components, marks shall be allotted for journal/lab record book, field work, experiments, practicum and oral/viva voce during the examination: 20% for journals, 60% for the experiment and 20% for the orals, or as recommended by the BoS and approved by the Academic Council, and notified by the University.
  - ii) Examiners shall take into account the regularity of the candidate in attending the Laboratory course, completeness of the exercises, presentation and style of writing the journal.
  - (iii) For subjects having field work, the candidate shall be required to submit the report of such field excursion(s) along with the journals for assessment.
  - (iv) For assessing the performance of the candidate in the assigned experiment, the examiner shall take into account the planning, procedure and technique followed by the candidate along with the readings/observations, results and presentation.
  - (v) For the viva/oral examination, the examiner(s) shall assess the knowledge of the candidate in the Course, as well as the experiment(s) performed by the candidate.
  - (vi) Record of the breakup of marks thus obtained by the candidate shall be maintained by the respective college for Semesters I to IV, in a sealed envelope for a minimum period of 4 years.
  - (vii) The practical examination shall be treated as an independent head of passing.
  - (viii) A candidate may be permitted, strictly on medical or other genuine grounds, to appear for a practical examination out of turn, irrespective of the timetable and the batch allotted to him/her, in the examination Programme for Semester V to Semester VIII issued by the University.
    - (ix) Such permission may be granted by the University if so recommended by the Principal of the college.
    - (x) This 'out of turn' appearance may be in the same college in a different batch or in a different college.
    - (xi) The candidate shall be required to remit the requisite fee for his/her being examined out of turn. (xii) The project shall be assessed by the Internal Examiner (Project Supervisor) and External Examiner for 50 marks each, as per the guidelines defined in the project manual.

### Student Attendance for B.A. B.Ed. Programme

The Minimum attendance of student-teacher shall have to be 80% for all course work and practicum, and 90% for school internship.

# **Integrated Teacher Education Programme (ITEP)**

#### 1. Introduction

The Integrated Teacher Education Programme (ITEP) is a four-year, eight-semester dual-major bachelor's degree program designed to prepare accomplished educators in alignment with the National Education Policy (NEP) 2020. The program offers specialization across different school stages and integrates pedagogical and disciplinary knowledge.

### 2. Program Structure

### 2.1 Duration and Stages

ITEP follows the NEP 2020 restructured education model (5+3+3+4). It specializes in four school stages:

- 1. Foundational Stage (Ages 3–8): Covers early childhood education and Grades 1 & 2.
- 2. Preparatory Stage (Grades 3–5): Builds on foundational learning with interactive pedagogy.
- 3. Middle Stage (Grades 6–8): Introduces subject-specific learning and teachers.
- 4. Secondary Stage (Grades 9–12): Focuses on multidisciplinary, subject-oriented study with flexibility and critical thinking development.

### 2.2 Degree Specializations

Graduates earn a dual-major degree such as:

- B.A. B.Ed. (Arts & Education)
- B.Sc. B.Ed. (Science & Education)
- B.Com. B.Ed. (Commerce & Education)

Each degree aligns with a chosen specialization stage.

### 2.3 Entry & Exit Options

ITEP provides flexibility with multiple exit points:

- 1 Year (2 Semesters) → Certificate
- 2 Years (4 Semesters) → Diploma
- 3 Years (6 Semesters) → Bachelor's Degree (Single Major)
- 4 Years (8 Semesters) → Dual-Major Bachelor's Degree

### 3. Admission & Eligibility

Completion of Grade 12 (or equivalent) with a minimum of 50% marks from a recognized board or university.

The college has applied to the Goa University and NCTE to offer the Integrated Teacher Education Programme at the college and will implement it as soon as the approval is granted.

#### **Admission Procedure**

- a) Admission in ITEP shall be through a suitable subject and aptitude test conducted by the National Testing Agency (hereinafter referred to as 'NTA') and shall be standardized keeping in view the linguistic and cultural diversity of the country.
- b) A single nation-wide entrance test called National Common Entrance Test (hereinafter referred to as 'NCET') will be conducted by NTA for admission to the 4 Year ITEP under the recommendations of NEP 2020. The mode of examination shall be online/Computer Based Test (hereinafter referred to as 'CBT') in multilingual pattern and its score would reflect the relative performance level of the candidate for merit-based selection to secure the admission. Scorecard shall be prepared by NTA and admission shall be done through centralised online counselling.

Link for Online Payment will be provided on the college website at the time of admission.

### Fee Structure

Fee structure for the Academic Year 2025-2026 for the B.Com. & B.A.B.Ed. programmes will be communicated to the students as and when the college is informed by the DHE and Goa University.

### **Refund of Tuition Fees**

a) If a student chooses to withdraw from the programme of study in which he/she is enrolled, the following fivetier system shall be followed for the refund of fees remitted by him/her.

- b) Caution Deposit & Security Deposit shall be refunded in full.
- c) In case of (1) in the table above, 5% of the fees paid by the student, subject to a maximum of Rs. 5000/- shall be deducted as processing charges from the refundable amount.
- d) Fees shall be refunded to an eligible student within fifteen days from the date of receiving a written application from him/her in this regard.
- e) The fees of students, who have been already admitted to a programme of the University and have paid the fees and are subsequently admitted to another programme, shall have to pay the fees for the final admission of that programme and claim the refund of the fees paid earlier, in which case no administrative charges shall be deducted from fees paid earlier by the student.
  - However, if the fees payable for the both the programmes are the same, the fees paid earlier shall be transferred to the final programme where admission is sought.
- f) All other cases of the refund of the fees will be decided on case to case basis on its merit.

### **Focus on Holistic Education**

### **Other Facilities**

#### Students' Aid Fund

The objective of this scheme is to render financial support to economically backward students to meet their tuition/ examination fees in part or full or, to purchase books or meet any other expense as approved by the college authorities. Every student is required to contribute Rs. 100/- p.a. at the time of admission. Financial support under this scheme shall be considered only for those students whose family income does not exceed Rs. 2 Lakh p.a. Applicants shall be required to produce income certificate from the competent authorities. The beneficiary should not be in receipt of any other scholarships/assistance, except merit scholarships for the said academic year. A student who fails in the final examinations or/and is irregular to class will not be eligible for any assistance under this scheme.

#### Parents Teachers Association

PTA was formed in the year 2012-13. It acts as an intermediary among parents, teachers and students. It undertakes various activities such as seminars, talks, financial assistance to needy students, academic support, etc. that benefits parents, students and teachers.

#### Alumni Association

The College has formed an alumni association with an objective to promote and foster mutually beneficial interaction between the Alumni and the present students of the College, and between the Alumni themselves. ## **Library Rules & Regulations**

#### DISCIPLINE

- 1. Identity Card is compulsory for getting access to the library.
- 2. Biometric entry is compulsory at the Library entrance.
- 3. All users must observe total silence in the library and its environs at all times.
- 4. Use of mobile phones is strictly prohibited in the library.
- 5. All bags, cases, folders etc. must be left in the luggage area in the library.
- Books removed from the shelves, if not required further, should be kept on the table nearest to them. Please do not try to shelve them yourself. Please remember that a book misplaced is a book lost.
- 7. Users are not allowed to leave their baggage overnight in the library. The library shall not take any responsibility for loss of personal property or books already signed out to a user.
- 8. Anyone caught marking, defacing or mutilating books or any other library resources shall have to pay for the damage.
- Good order must be observed in the library at all times for example placing of feet on furniture, eating and drinking, smoking, sleeping etc. shall not be allowed.
- 10. Group discussions are not allowed and noise must be kept to a minimum and should not disturb any other user in the library.
- 11. Shifting of chairs from one place to another place is strictly prohibited.
- 12. If a student feels any deficiency in the services of the Library, the same may be brought to the notice of the Librarian immediately for necessary improvement in the services of the Library.
- 13. Any violation of the library rules by a student shall stop him/her from availing Library services.
- 14. The library is only for the staff members and bonafide students of the college, outsiders and exstudents will NOT be allowed in the library without prior permission of the Librarian OR the Higher Authorities.
- 15. The librarian may recall any book from any member at any time and the member shall return the same immediately.

#### LEARNING RESOURCE BORROWING PROCEDURE

- 1. A user must be a registered student for the current Academic year.
- 2. All students must present their college ID card before borrowing any learning resources from the

Library.

- 3. Students are allowed to borrow a maximum of two books for a period of one week.
- 4. Students are not allowed to borrow books on behalf of others or transfer borrowed learning resources to other students.
- 5. Students who repeatedly fail to return the books on due date will lose the privilege of membership of the library.

#### OVERDUE CHARGES/ FINES

A late fee will be charged if the books are not returned within the due date as per the norms shown below:

- For a week after the due date: Rs. 1/- per day per book
- 2. From 2nd week onwards: Rs. 2/- per day per book
- 3. After one month: Rs. 5/- per day per book

#### LEARNING RESOURCES CAN ONLY BE USED WITHIN THE LIBRARY

- 1. Reference books like Handbooks, Dictionaries and Encyclopedias.
- 2. Newspapers
- 3. Journals and magazines.

#### DAMAGE/LOSS OF LIBRARY RESOURCES

- Once a book is issued to the student, he/she shall be held solely responsible for any damage spoilage, or mutilation of the book detected subsequently. Students will be charged for repair or replacement of books and other Library resources to which they have caused damage.
- 2. Lost books must be reported to the librarian immediately and replaced or paid for within 30 days.
- 3. Lost library books that are recovered, must be handed over to the librarian as they remain the property of the college library.

#### INTERNET ACCESS

- 1. Internet facility within the Library premises will be provided from 9.00 a.m. to 4.00 p.m. from Monday to Saturday.
- 2. Students are informed that use of internet will be monitored.
- 3. If a student is found visiting inappropriate sites, strict action will be taken.
- 4. Access is available only for academic purpose, as such social networking sites are banned.
- 5. The speed and availability of the internet will depend upon the technical feasibility.
- 6. Any other matter not covered under the above rules will be decided by the system administrator in consultation with the head of the institution.

### **Student Code of Conduct**

The College Students' Discipline and Conduct Rules 2019

#### 1. SHORT TITLE AND COMMENCEMENT

- (a) These Rules shall be called "The College Students' Discipline and Conduct Rules 2019" hereafter referred to as the "Rules".
- (b) These Rules shall come into force with effect from the date of their notification.

#### 2. APPLICATION OF RULES

- (a) These Rules shall apply to all students of the affiliated college whether admitted prior to the commencement of these Rules or after the commencement of these Rules.
- (b) Any breach of discipline and conduct committed by a student inside or outside the College Campus shall fall under the purview of these Rules.
- (c) Without prejudice to the generality of the power to enforce discipline under Section 22 (q) of the Goa University Act, 1984 and Statue 26 thereunder, the acts mentioned in Rules 4 shall amount to acts of misconduct or indiscipline or both.
- (d) These rules are not meant to deny the democratic rights of the students to dissent/air their grievances/ protest in a peaceful and lawful manner.
- (e) Peaceful and lawfully conducted sit-ins/dharanas at a designated place with prior intimation to the College Principal will not invite any punishment under these rules.

#### 3. ACTS OF MISCONDUCT AND INDISCIPLINE:

#### (a) Acts of misconduct and indiscipline Category-I:

- i) Causing disturbance within the University premises, Laboratory or Reading Room, Common Room, Playground or Hostel.
- ii) Any act leading to diverting the attention of the students from the Lectures or of the teacher from Teaching.
- iii) Insubordination and/or disrespect to the teacher within or outside the University premises.
- iv) Habitual inattention to classwork and assignments.
- v) Disturbing a class from outside by loitering aimlessly in the corridors, making noise.
- vi) Picking up quarrel with the teaching or nonteaching staff or with other students.
- vii) Using filthy language and abuses in the University premises or 'Sports-grounds'
- viii) Smoking openly within the University campus.
- ix) Playing any kind of musical instrument inside the class or outside during class hours.

- x) Hunger strikes, dharnas, group bargaining and any other form of protest by blocking entrance or exit of any of the academic and/ or administrative complexes or disrupting the movements of any member of the University Community.
- xi) Furnishing false certificates or false information in any manner to the University.
- xii) Teasing or disrespectful behavior or any misbehavior with a boy/girl student, staff member/ visitor.
- xiii) Causing or colluding in the unauthorized entry of any person/guest into the Campus or in the unauthorized occupation of any portion of the University premises, including residential quarters/hostels or residence by any person.
- xiv) Unauthorized occupation of the hostel rooms or unauthorized acquisition and use of University furniture in one's hostel room or elsewhere.
- xv) Damaging or defacing, in any form any property of the University or the property of any member of the University community.
- xvi) Not disclosing one's identity when asked to do so by a faculty member or employee or security staff of the University who is authorized to ask for such identity.
- xvii) Improper behavior while on tour or excursion.
- xviii) Coercing the medical staff to render medical assistance to persons not entitled for the same or any other disorderly behavior in the Health Centre of University.
- xix) Blockade or forceful prevention of any normal movement of traffic, violation of security or safety rules notified by the University.
- xx) Littering of any kind of waste including plastic waste in the College buildings, grounds/roads/premises.
- xxi) Disturbing other students/ teachers using a mobile phone inside the class or outside during class hours.
- xxii) Driving and parking the vehicles on College campus in violation of guidelines to that effect.
- xxiii) Distributing any material related to political parties/movements.
- xxiv) Any other act which may be considered by the Principal or any other competent authority to be a minor act of violation of discipline and conduct.

#### (b) Acts of misconduct and indiscipline Category-II:

 Repetition of acts given under Category-I of indiscipline in spite of repeated warnings and penalties imposed.

- ii) Attending the College dressed in a manner contrary to social norms prevailing from time to time or violation of dress code if any.
- iii) Indecent exposure in a proactive manner or behaving in a manner tending to rouse baser passions among the members of the same or opposite sex.
- iv) Disfiguring the walls, floors, furniture etc. of the University.
- Forcibly entering/ reaching places which have restricted entry or unauthorizedly handling of equipment or performing acts which would be a threat to one's life.
- vi) Instigating others to commit acts of indiscipline.
- vii) Engaging in any attempt at wrongful confinement of any member of the faculty, staff, student or anyone camping inside the Campus.
- viii) Any Intimidation of or insulting or abusive behavior towards a student, staff or faculty or any other person.
- ix) Wanton destruction of College properties.
- x) Consuming or possessing narcotic drugs or other intoxicants or alcohol anywhere in the College premises.
- xi) Indulging in criminal acts of any kind under the law of land including gambling and possession of arms/weapons.
- xii) Arousing communal, caste or regional feelings or creating disharmony among students.
- xiii) Demonstration of disloyalty to the country, its constitution and its flag.
- xiv) Ragging of any kind tending to cause physical and mental torture to other students or forcing others to submit to indignity and nuisance.
- xv) All acts of violence and all forms of coercion such as gheraos, sit-ins or any variation of the same which disrupt the normal academic and administrative functioning of the College and or any act which incites or leads to violence.
- xvi) Gheraos, laying siege or staging demonstrations around the residence of any member of the College Community or any other form of coercion, intimidation or disturbance of right to privacy of the residents of the campus.
- xvii) Sexual harassment of any kind which shall also include: unwelcome sexual proposition/ advancements, sexually graphic comments of a body unwelcome College Prospectus 2018-19 Page 135 touching, patting pinching or leering of parts of the body or persistent offensive or unwelcome sexual jokes and or comments.
- xviii) Committing forgery, tampering with the Identity Card or College records, impersonation, misusing College property (movable or immovable), documents and records, tearing of pages of, defacing, burning or in any way destroying the books, journals, magazines and any material of library or unauthorized photocopying or

- possession of library books, journals, magazines or any other material.
- xix) Any act of moral turpitude.
- xx) Use of abusive, defamatory, derogatory or intimidatory language against any member of the College Community.
- xxi) Any other act or acts which the Principal considers as major acts of misconduct and indiscipline.
- xxii) Publishing or posting derogative comments against any student/teaching staff/administrative staff of the college or any other person on social media.

#### 4. PUNISHMENT

The competent authority may impose any one or suitable combination of the following punishments on any student found guilty of any of the acts of indiscipline or misconduct mentioned under Category-I or Category-II as the case may be, in Rule 4.

#### Category-I:

- 1) Admonition/Reprimand.
- 2) Sending the student out of his class and not letting him into his class up to a maximum of two consecutive periods.
- 3) Marking the student absent on repeating the misconduct at Sr No. 2.
- 4) Fine up to Rupees Twenty Thousand depending upon gravity of the issue.
- 5) Recovery of any kind, such as scholarship/fellowship, any dues, cost of damages, etc.
- 6) Withdrawal of any or all facilities available to a student as per, various College Rules (such as Scholarship/ Fellowship, Hostel etc.) permanently or for a time period up to two semesters.
- 7) Stoppage of any or all academic processes.
- 8) Rustication up to two semesters and/or Declaring any hostels, premises, building or the entire College Campus out of bounds to any students.

#### Category-II:

- Cancellation of admission or withdrawal of degree or denial of registration for a specified period.
- 2) Rustication up to four semesters and/or declaring any part or the entire College Campus out of bounds.
- 3) Fine up to Rupees Fifty Thousand depending upon gravity of the issue.
- 4) Expulsion.

#### 5. Student ID Card

Every student must be in possession of a valid identity card. He/she must wear it on campus at all times. In case of loss of ID card, the student has to pay **Rs. 500/-** for the issue of duplicate ID Card.

#### 6. Student Uniform

As per the rules prescribed by NCTE, B.A.B.Ed students should wear uniform as prescribed by the college during the college hours.

# **Excerpts from Ordinance OA-17 relating to Minimum Attendance for Eligibility to Appear for Examinations Conducted by Goa University**

#### OA-17.3 Attendance and Eligibility to Appear for Examinations

- (i) The attendance shall be taken by the teacher for each lecture/ tutorial/ practical or any other component of teaching separately. He/She shall maintain such a paper-/course-wise Attendance Register.
- (ii) Attendance shall be taken on a day to day basis for all the students and shall be cumulative of all the months of the Semester / Term / Year (in case of annual examination), as the case may be, for deciding the eligibility to appear for the respective examination. The statement of the attendance shall be prepared paper-/course-wise and month-wise and the same shall be displayed on the Notice Board. A copy of this statement shall be sent to the University for records.
- (iii) If more than the prescribed number of Lectures / Practicals for a paper/course have been engaged by the teacher(s), then, for the purpose of compilation of attendance, the number of lectures actually engaged as well as attended shall be proportionately scaled down with respect to the prescribed number of lectures / practicals for the paper / course.
- (iv) A student registered in a Semester / Term / Year, for any Course (degree or diploma), shall be required to have a minimum cumulative attendance of 75% of the total lectures and practicals prescribed for the course during that Semester / Term / Year. Although the attendance shall be cumulative for all the papers/courses taken together, in the given Semester / Term / Year, a student shall be required to have a minimum of 50% attendance in any individual paper / course.
- (v) A student, having less than 75% cumulative attendance in a Semester/Term / Year and/or less than 50% attendance in individual paper/course, shall not be eligible to appear for that Semester / Term / Annual Examination. Such student shall have to seek re-admission to the Course / Programme during the subsequent Academic Year / Term / Semester by paying requisite fees. However, such student shall not be treated as fresh applicant for the admission if the readmission is in the same institution. Re-admission to professional colleges for the First Year of the course shall be as per the admission rules for these courses. These students shall not answer CET.
- (vi) For a student registered for subject /subjects having practical component, attendance for both theory and practical component shall be treated separately for the requisite attendance mentioned above.
- (vii) Attendance of a student in an institution for a course shall be transferred to another institution if the student continues the same course in the new institution.
- (viii) (Effective from 2nd March, 2015) A student representing the Institution / University / State / Country in extracurricular activities such as NCC /NSS / Sports / Cultural events, on obtaining prior approval of the Principal / Dean / Head of Department, shall be treated as 'on duty' at the lectures/practicals missed by him / her and shall be marked as 'D' in the Attendance Register. Absence due to such activities shall be supported by documentary evidence issued by appropriate authority such as Commanding Officer of NCC, Director of Youth Affairs, Director/Asstt. Director of Sports in Government / University or an authorized official of these and other similar bodies. However, in such cases, for the purpose of compilation of cumulative as well as paper / course-wise attendance, the number of lectures/practicals for the paper / course shall be calculated after adding the lectures/practicals under 'D' and considered as such.
- e.g. No. of lectures / practicals attended+ D x 100

  No. of lectures/practicals engaged
- (ix) Absence on medical grounds for more than four continuous working days is required to be supported with a Medical Certificate which should be submitted within seven days after re-joining the class. Absence on medical grounds shall be offset against the 25% concession in the attendance already granted. However, if such absence exceeds 25% and is found genuine, the student may request for the condonation of the same. The Principal / Dean / Head of the Department shall examine such absence on a case-to-case basis.
- (x) Any case not covered under the above clauses but recommended by the Principal / Dean / Head of the Department for condonation shall be referred to a Committee consisting of (i) Vice-Chancellor (Chairman), (ii) Registrar and (iii) Principal of the Institution/Dean of the College / Head of the Department concerned, as members.
- (xi) (Effective from 20th September, 2014) For Programmes in the field of Medicine, Dental, Ayurveda, Homoeopathy, Nursing, Engineering and such others, which are governed by the regulations of Central governing bodies such as MCI, DCI, AICTE, CCIM, Indian Nursing Council (INC), the norms prescribed by the respective bodies shall be followed with regard to the minimum attendance requirements as amended from time to time.
- (xii) A student, who has any grievance about the attendance record, may bring the same to the notice of the Head of the PG Department / Dean or Principal of the College, in writing, within three days from the date of its display on the Notice Board. The Head of the PG Department / Dean or Principal of the College on receipt of such a complaint, shall verify the accuracy of attendance records and allow the aggrieved student to inspect the records, if necessary, and shall dispose of the complaint preferably within a period of seven days.

## **Annexure - I: UGC Regulations on Anti-Ragging**

#### UNIVERSITY GRANTS COMMISSION

UGC REGULATIONS ON CURBING THE MEANCE OF RAGGING IN HIGHER EDUCATIONAL INSTITUTIONS, 2009. (Under Section 26 (1) (g) of the University Grants Commission Act, 1956) Dated June, 2009

#### PREAMBLE

In view of the Directions of the Hon'ble Supreme Court in the matter of "University of Kerala V/S Council, Principals, Colleges and others" in SPL no. 24295 of 2006 dated 16.05.2007 and that dated 08.05.2009 in Civil Appeal number 887 of 2009, and in consideration of the determination of the Central Government and the University Grant Commission to Prohibit, prevent and eliminate the scourge of ragging including any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student, or indulging in rowdy or indisciplined activities by any student or students, which causes or likely to cause annoyance, hardships or psychological harm or to raise fear or apprehension thereof in any fresher or any other students, or asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of sane, torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student, in all higher education institution in the country, and thereby, to provide for the healthy development, physically or psychologically, of all students, the University Grant Commission, is consultation with the Councils, brings forth this Regulation.

In exercise of the powers conferred by clause (g) of sub-section (1) of section 26 of the University Grants Commission Act, 1956, the University Grant Commission hereby makes the following Regulations, namely

What constitutes Ragging?

- a. Ragging constitutes one or more of any of the following acts: a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b. Indulging in rowdy or indisciplined activities by any

- student or student which cause or likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- c. Asking any student to do any act which such student will not in the ordinary course to do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- d. Any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher,
- e. Exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. Any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- Any act or abuse by spoken words, emails, post, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student;
- I. Any act that affects the mental health and selfconfidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student

#### Administrative action in the event of Ragging:

The institution shall punish a student found guilty of ragging after following the procedure and in the manner prescribed herein under:

a) The Anti-Ragging committee of the institution shall take an appropriate decision, in regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging established in the recommendations of the Anti-Ragging Squad.

- b) The Anti-Ragging Committee may, depending on the nature and gravity of the guilt established by the Anti-Ragging Squad, award, to those found guilty, one or more of the following punishments, namely:
  - Suspension from attending classes and academic privileges.
  - II. Withholding / withdrawing scholarships / fellowship and other benefits.
  - III. Debarring from appearing in any test / Examination or other evaluation process.
  - IV. Withholding results.
  - V. Debarring from representing the institution in any Regional, National or International meet, tournament, youth festival, etc.
  - VI. Suspension / expulsion from the hostel.
  - VII. Cancellation of admission
  - VIII. Rustication from the institution for a period ranging from 1 to 4 semesters.
    - IX. Expulsion from the institution and consequent debarring from admission to any other institution for a specified period.

- X. Fine which may extend up to 2.5 lakhs. Provided that where the person committing or abetting the act of ragging are not identified, the institution shall resort to collective punishment.
- c) An appeal against the order of punishment by the Anti-Ragging Committee shall lie;
  - In case of an order of an institution, affiliated to or constituent part, of a University to the Vice-Chancellor of the University;
  - ii. In case of an order of a University, to its Chancellor.
  - iii. In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be.


