ORDER

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 1.12.2014.

2. And whereas, the institution Vidya Prabodhini College of Commerce, Education, Computer & Management, Vidyanagar, Alto, Porvorim- Goa, Taluka- Bardez-Goa, District- North Goa- 403521, Goa. has by affidavit consented to come under New Regulations and sought Recognition for an two basic units (50 students each unit) in B.A. B.Ed.(Integrated Course) 4 years. Programme which require additional facilities.

3. And whereas, it has been decided to grant recognition to the institution to have two basic units of 50 students subject to the institution fulfilling following conditions namely,

- (i). The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.
- (ii). The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified Performa available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available; otherwise it can also be given to the Visiting team at the time of inspection.
- (iii). The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

4. Now therefore, in the light of the above and in terms of Section 14(3) (a) of NCTE Act 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to Vidya Prabodhini College Of Commerce, Education, Computer & Management, Vidyanagar, Alto, Porvorim- Goa, Taluka- Bardez-Goa, District- North Goa- 403521, Goa for conducting B.A. B.Ed.(Integrated Course) Programme of 4 years duration with an annual intake of 100 students (2 basic units of 50 students each unit) from the academic session 2015-16 subject to fulfilment of the conditions mentioned herein before 31.10.2015

5. Further, the recognition is subject to fulfilment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc. as applicable.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.


7. The institution shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- a) Sanctioned programmes along with annual intake in the institution;
- b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
- c) Name of faculty members who left or joined during the last, quarter;
- d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- e) Fee charged from students;
- f) Available infrastructural facilities;
- g) Facilities added during the last quarter;
- h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
- i) The affidavit with enclosure submitted along with application.
- j) The institution shall be free to post additional relevant information. if it so desires.
- k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

Note:- (i) WRC in its 218th meeting observed that the Staff list duly approved by the competent authority has been received. It is seen that so far only three faculty members have been appointed whereas for an Integrated course, staff of 16 for two units are required as per NCTE Regulations, 2014. Since, this is a pending application, as per the guidelines issued by NCTE hqrs vide their letter dated 06.02.2015, Recognition is granted from the academic session 2015-2016 under Clause 7(16) of NCTE Regulations, 2014 for two basic units of 50 students each with the stipulation that the full contingent of staff will be appointed before the commencement of the session.

(ii) The attention of the institution should also be drawn to clause 2 (b) of NCTE Regulations, 2014, according to which every teacher training institution has to be a composite institution by session 2016-2017, as stipulated in the guidelines issued by the NCTE hqrs vide letter dated 06.02.2015.

If the institution Contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and Orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act.
